Procedure for Filling Out the Temporary Use of Frequency Spectrum “Applicant Registration”



Considerations

According to “Temporary Use of Frequency Spectrum” policies, only authorized persons can register to request frequencies.

Before applying for the “Temporary Use of Frequency Spectrum,” you must fill out the following form:

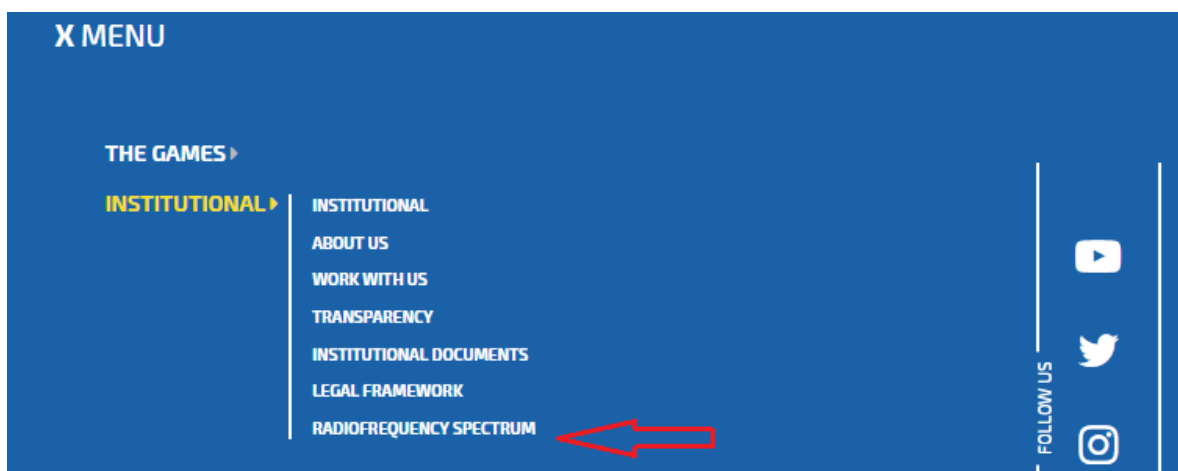
For the Applicant Registration you must follow the following procedure below:

Applicant Registration Procedure

1. Click on the link <https://www.lima2019.pe> to register, you will see:



2. Click the “Institutional” tab and then “Radiofrequency Spectrum:”

MTC, as the Telecommunications Regulatory Agency of Peru, in coordination with the Special Project for the Preparation and Development of the XVIII Pan American Games and Sixth Parapan American Games Lima 2019, will assign the temporary radio frequency in response to the request.

Therefore, it is important that all delegations and authorized Suppliers register wireless devices before the start of the Lima 2019 Games.

Considerations

All wireless equipment must be authorized and registered before its use in Peru.

A frequency will be assigned to all registered and authorized devices. Once the frequency is assigned, the user must bring their configured equipment with the information provided.

All registered and authorized equipment will be tagged with a compliance label (**Test and Labeling**) at the Lima 2019 Radio Frequency Spectrum offices before being transferred to the appropriate venues.

Any user wishing to set up a private Wi-Fi network during the Games must register on this form beforehand.

Users do not need authorization to use frequencies with the following technological devices: mobile phones, tablets, remote key fobs and bluetooth headsets.

All fields marked with * must be filled in.
